

Objectives and investment policy

Objectives

The objective of this alternative investment fund is to achieve investment growth in any type of market conditions (absolute return). The share class is accumulating.

Investment policy

The fund seeks exposure to volatility risk premia embedded in equities, fixed income, credit, currencies and money market instruments from anywhere in the world with a focus on developed markets. The investment strategies are implemented using primarily derivatives such as options, futures and swaps. The fund will invest its remaining assets in high credit quality debt instruments, such as bonds issued by governments and credit institutions, money market instruments and/or short-term deposits.

The fund may use derivatives for hedging and efficient portfolio management, as well as for investment purposes. Expected leverage is 800% to 1,000% with an expected maximum of 4,000%.

The fund is categorised as article 8 under SFDR and promotes environmental and/or social characteristics, as well as good governance practices, through screening, exclusions, investment analysis and decision-making as well as active ownership. The fund follows Danske Invest's responsible investment policy. Recommendation: The fund may not be appropriate for investors who plan to redeem their money within 3 years.

Latest fund report

The return in October for Global Cross Asset Volatility Class W p was +0.08%.

In October, macro data led the market to reduce the expected speed of rates cutting from the US central bank

The S&P 500 index declined 1.0% over the month after having been up 1.8% mid-month.

The 10-year German government yield rose 27bp to 2.39%.

The average risk consumption during October was 56% of maximum Value-at-Risk.

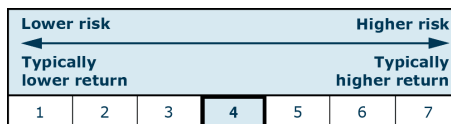

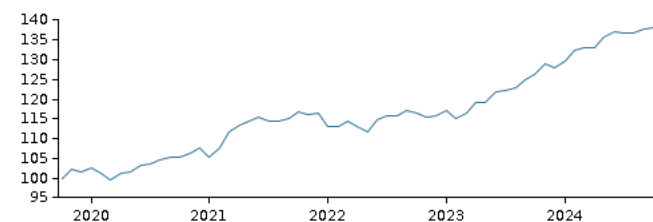

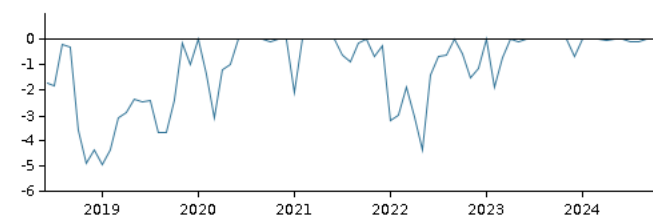


Return in the period: 31.10.2019 - 31.10.2024
